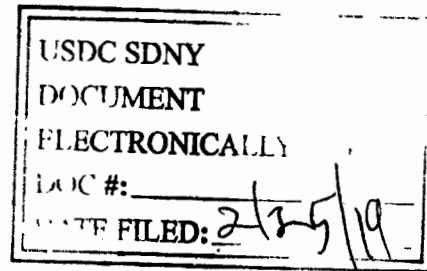


**MOTION FOR PRO HAC VICE


