- 1025. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1025 of the Second Amended Complaint.
- 1026. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1026 of the Second Amended Complaint.
- 1027. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1027 of the Second Amended Complaint.
- 1028. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1028 of the Second Amended Complaint.

Twenty-Second Count: (For Relief Only) Alter Ego against the Huberfeld Family Foundation in respect of Counts One, Two, Three, Four, Five and Six

- 1029. Defendant repeats and reasserts each of its responses to Paragraphs 1- 1028 as if fully set forth herein.
- 1030. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1030 of the Second Amended Complaint.

- 1031. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1031 of the Second Amended Complaint.
- 1032. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1032 of the Second Amended Complaint.
- 1033. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1033 of the Second Amended Complaint.
- 1034. Defendant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 1034 of the Second Amended Complaint.

AFFIRMATIVE DEFENSES

FIRST AFFIRMATIVE DEFENSE

Plaintiffs have failed to state a claim upon which relief may be granted.

SECOND AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred because the Plaintiffs have acted in bad faith.

THIRD AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred by the doctrine of unclean hands.

FOURTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred by the doctrine of estoppel.

FIFTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred by the doctrine of waiver.

SIXTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred by applicable statutes of limitation.

SEVENTH AFFIRMATIVE DEFENSE

At all relevant times Seth Gerszberg acted in a commercially reasonable manner.

EIGHTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred by the doctrine of laches.

NINTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred because Plaintiffs have failed to mitigate their damages.

TENTH AFFIRMATIVE DEFENSE

Plaintiffs' damages, to the extent they have sustained any, are due to their own actions or failures to act and not due to the actions of Seth Gerszberg.

ELEVENTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred because Seth Gerszberg owed no duties to Plaintiffs at any relevant time.

TWELFTH AFFIRMATIVE DEFENSE

Plaintiffs' claims are barred for lack of standing.

THIRTEENTH AFFIRMATIVE DEFENSE

Defendant reserves the right to interpose such other defenses and objections to Plaintiffs' claims as continuing investigation may disclose.
