

NOTICE OF REQUEST FOR VACATUR OF CERTIFICATE OF DEFAULT AND WITHDRAWAL OF MOTION FOR A DEFAULT JUDGMENT AGAINST DEFENDANT EZRA BEREN

WHEREAS, on July 24, 2019, pursuant to Local Civil Rule 55.1, Plaintiffs Martin Trott and Christopher Smith, as Joint Official Liquidators and Foreign Representatives of Platinum Partners Value Arbitrage Fund L.P. (in Official Liquidation) and Platinum Partners Value Arbitrage Fund L.P. (in Official Liquidation) (together, "Plaintiffs") requested that the Clerk of this Court enter a Certificate of Default (the "Certificate") against Defendant Ezra Beren ("Beren") in the above-captioned actions (Doc. 569, 440);

WHEREAS, on July 25, 2019, the Clerk of the Court issued the Certificate noting the default of Beren (Doc. 570, 441);

WHEREAS, on September 30, 2019, pursuant to Federal Rule of Civil Procedure 55 and Local Civil Rule 55, Plaintiffs moved for a default judgment against Beren (the "Motion") (Doc. 646, 462);

WHEREAS, on October 4, 2019, Beren filed a Motion to Vacate the Default and Crossmotion to Vacate Clerk's Certificate of Default in the action captioned *Trott, et ano. v. Platinum Management (NY) LLC*, No. 1:18-cv-10936-JSR (S.D.N.Y.), together with supporting declarations of Ezra Beren, Jonathan Beren, Denise Beren, Tammy Beren, and S. Christopher Provenzano (Doc. 468-474); and

WHEREAS, based upon Beren's agreement to accept service of the Second Amended Complaint in these action (Doc. 226, 285) as of October 7, 2019, Plaintiffs have agreed to request that the Certificate be vacated and to withdraw the Motion.

UPON THE FOREGOING PREMISES, Plaintiffs hereby respectfully request that the Clerk of the Court vacate the Certificate of Default and Plaintiffs hereby withdraw the Motion for a Default Judgment, both without prejudice.
